Liability Waiver

It is the purpose of this Agreement to exempt, waive and relieve the Harpoon Brewery, Friends of Norris Cotton Cancer Center, USA Track & Field, the G&C Development Corporation, agents, sponsors, contractors and the Town of Windsor, liability for personal injury, property damage and wrongful death, including if caused by negligence, including the negligence, if any, of the Released Parties.

In consideration of my entry being accepted, I hereby for myself, heirs, executors and administrators, waive and release any and all rights and claims for damage I may have against the Released Parties for any and all injuries suffered by me while competing in the Harpoon Octoberfest Road Race.

I acknowledge, understand and assume all risk related to running and any other activities affiliated with the Harpoon Octoberfest Road Race, and understand that running involves risks to my person including bodily injury, partial or total disability, paralysis and death, and damages which may arise there from and that I have full knowledge of by my negligence or the negligence of others, including the Released Parties. These risks and dangers include, but are not limited to, those arising from motorists, road conditions, weather, pedestrians, equipment malfunctions, acts of God, and other runners. I acknowledge that I will be running on public, not private, road said risks. These risks and dangers may be caused ways. I further acknowledge that there may be risks and dangers not known to me or not reasonably foreseeable at this time. I acknowledge, understand, and agree that all of the risks and dangers described throughout this Agreement, including those caused by my negligence and/or others, are included within the waiver, release, and relinquishment described in the preceding paragraphs

PHOTO RELEASE: I represent that I am over the age of 21. I agree that photograph(s) of me ("Photographs") may be taken by employees, agents or representatives of the Harpoon Brewery ("the Brewery").
